Statement by the Government of the Cooperative Republic of Guyana

The Government of the Cooperative Republic of Guyana has taken note of the action taken today, April 3, 2024, by the President of the Bolivarian Republic of Venezuela to promulgate "the Organic Law for the Defense of Guayana Esequiba."

This attempt by Venezuela to annex more than two-thirds of Guyana's sovereign territory and make it part of Venezuela is an egregious violation of the most fundamental principles of international law enshrined in the United Nations Charter, the Charter of the Organisation of American States and customary international law. It also contradicts the letter and spirit of the Joint Declaration of Argyle for Dialogue and Peace between Guyana and Venezuela agreed to on December 14, 2023 in St Vincent and the Grenadines. This unlawful act calls into question Venezuela's obligation to abide by the principles of that Declaration. In this light, the Government of the Cooperative Republic of Guyana wishes to put on notice the Government of the Bolivarian Republic of Venezuela, the Governments of the Caribbean Community and the Latin American and Caribbean Community of Nations, as well as the Secretary General of the United Nations and the Secretary General of the Organisation of American States, that it will not countenance the annexation, seizure or occupation of any part of its sovereign territory. Guyana has always stood by the principles of the United Nations Charter, the rule of law and the peaceful settlement of disputes.

It is as a result of the 1966 Geneva Agreement, to which Venezuela and Guyana are parties, that the International Court of Justice has ruled that it has jurisdiction to make a decision on the case brought before it by Guyana regarding the validity of the 1899 Arbitral Award which definitively settled the land boundary between the two countries. The Court's decision will be final and binding on both parties. If Venezuela wants to contest title to the territory in question, the proper forum is the International Court of Justice, which will decide the issue objectively and according to the law.

Furthermore, the offensive and undignified statements made by President Maduro about the President of the Cooperative Republic of Guyana have not gone unnoticed. It is unfortunate that the commitment made at Argyle to "the pursuance of good neighborliness, peaceful coexistence, and the unity of Latin America and the Caribbean" is now again seriously threatened by President Maduro's words and action today.

Statement by the Government of the Cooperative Republic of Guyana

The Government of the Cooperative Republic of Guyana takes notice that the Government of the Bolivarian Republic of Venezuela made a submission today to the International Court of Justice in keeping with the Court's stipulated timeline for the receipt of Venezuela's Counter Memorial on the merits of the case concerning the Arbitral Award of 3 October 1899 (Guyana v. Venezuela) which is pending before it.

This case, which was filed by Guyana in March 2018, seeks the Court's decision on the validity of the Arbitral Award which finally determined the land boundary between the two countries. The Court has already ruled that it has jurisdiction over the controversy and will decide the issue on the merits.

Guyana has repeatedly called on Venezuela to participate fully in the judicial proceedings and comply with the Court's rulings, and therefore welcomes Venezuela's submissions on the substantive issues that the Court will ultimately decide. Guyana notes that CARICOM and the Commonwealth and other members of the international community have also been urging Venezuela to participate in the proceedings before the ICJ.

Guyana considers that it is beneficial to the Court to have before it the submissions of both parties on the validity of the 1899 Arbitral Award and the settlement of the international boundary. Guyana made its submissions in April 2023. With the submissions of both States before it, the Court will be able to take all arguments and evidence into account and issue a more informed judgement, which will be final and binding on the parties.

Guyana has consistently pledged to abide by the Court's Judgement.

Venezuela's actions threaten regional peace, security - OAS, CARICOM

The General Secretariat of the Organization of American States (OAS) and the Caribbean Community (CARICOM) have condemned the Venezuelan government's approval of the "Law for the Defense of Essequibo," which attempts to annex more than two-thirds of Guyana's territory and make it part of Venezuela.

In a press release issued on Monday, the OAS secretariat stated that this action is contrary to the most basic principles of international law and indicative of the country's "dictatorial pattern."

"Regional peace and security depend on stopping the Venezuelan regime from advancing these threatening objectives," the statement read.

It continued, "International Law condemns the crime of aggression, condemns the threat of aggression, condemns unilateral actions to resolve bilateral problems, condemns non-compliance and violation of current Arbitration Awards, and as an international community, we must condemn bellicose attitudes and intimidation of countries and international actors."

The OAS once again signalled its backing for Guyana and commended the country's firm stance in respecting the jurisdiction of the International Court of Justice in this case.

CARICOM has also added to the heap of international condemnation for Venezuela's expansionist agenda, deeming its latest move an 'unacceptable' and 'potentially dangerous' escalation of tensions.

"In its adoption of "the Organic Law", the Government of the Bolivarian Republic of Venezuela has acted unilaterally, precipitously, and potentially, dangerously. In the process, it has: (i) offended "the Joint Declaration of Argyle for Dialogue and Peace between Guyana and Venezuela" of 14 December 2023; (ii) subverted international law; and (iii) signaled a possible embrace of an unworthy aggression to achieve its own articulated goals or purposes," the community said in a statement released on Monday. CARICOM also impressed upon the Venezuelan government to refrain from any further actions that would hinder regional and hemispheric peace and stability.

The community urged patience and calmness, as the two countries await the ruling from the International Court of Justice.

"We insist that dialogue and adherence to international law are the only viable paths to achieve a just and lasting settlement of the issues at hand. The alternatives are too horrific to contemplate."

On Monday, President Dr Mohamed Irfaan Ali reaffirmed his government's commitment to the maintenance of peace in the region, and its respect for the principles of international law.

The longstanding border controversy between Guyana and Venezuela was settled through an Arbitral Award in 1899.

However, during the 1960s, when Guyana was on the brink of gaining independence, Venezuela's claims to the country's territory resurged.

The case was subsequently taken to the ICJ, where it awaits a ruling.

In the case, Guyana is seeking that the court affirm the validity and binding effect of the 1899 Award.

UN Security Council to discuss Venezuela's increasing moves to seize Essequibo; CARICOM worried about "unworthy aggression"

8 April 2024

The United Nations Security Council (UNSC) is Tuesday set to discuss Venezuela's latest effort to lay claim to the Essequibo Region, a move that the 15-nation Caribbean Community (CARICOM) is worried that could lead to physical action against Guyana.

CARICOM said that in its adoption of "the Organic Law for the Defence of Guyana Essequiba", the Venezuelan government has acted unilaterally, precipitously, and potentially, dangerously. In the process, it has... signaled a possible embrace of an unworthy aggression to achieve its own articulated goals or purposes," CARICOM said.

Foreign Secretary, Robert Persaud said the UNSC would meet on Tuesday, at President Irfaan Ali's request, to address Venezuela's President, Nicolas Maduro's "violation of the rules of international law" that require States to respect the sovereignty, territorial integrity and political independence of others. He also said the UNSC meeting would be held against the backdrop of the International Court of Justice's order that prohibits Venezuela from taking any action that interferes with Guyana's administration of the 160,000 square kilometre Essequibo Region.

Foreign Affairs Minister Hugh Todd said that after the deliberations Guyana would be expecting the UNSC to issue a strong statement that "conforms to the rule of international law." He explained that Guyana decided to ask the UNSC to discuss Venezuela's latest actions because all nation states subscribe to the UN Charter. "Fundamentally, the UN Security Council is the premier organ to discuss Venezuela's violations is what is necessary as a member of the international community." he said.

CARICOM said Venezuela's adoptionof the "Organic Law" means that country has acted unilaterally, precipitously, and potentially, dangerously and so has offended "the Joint Declaration of Argyle for Dialogue and Peace between Guyana and Venezuela" of 14 December 2023 and subverted international law.

The regional bloc said the "unacceptable escalation of tensions" between the two South American neighbours "has threatened to undermine peace and security in Latin America and the Caribbean."

Venezuela, through the referendum, has already included Essequibo in its official map.

Earlier Monday, Guyana welcomed Venezuela's decision to submit its key arguments to the International Court of Justice, saying that doing so would allow that judicial body to "take all arguments and evidence into account and issue a more informed judgement, which will be final and binding on the parties."

But Venezuela defended its decision to submit its main arguments to the International Court of Justice (ICJ) in the border dispute with Guyana, saying it does not change its position of non-recognition of that United Nations (UN) judicial body. "The delivery of this document does not imply the consent of Venezuela or the recognition of the jurisdiction of the Court in the territorial controversy over Guayana Esequiba, nor of the decision it may adopt on this matter," the Venezuelan Foreign Ministry said in a statement.

Venezuela said it wants Guyana to return to bilateral talks which the latter has said were fruitless after 50 years. Guyana in 2018 asked the ICJ to determine the validity of the 1899 Arbitral Tribunal Award that settled the land boundary with its Spanish-speaking neighbour.

UN Security Council supports respect for territorial integrity, international law- Guyana 11 April 2024

The United Nations Security Council (UNSC) on Tuesday unanimously supported respect for sovereignty, territorial integrity and international law, at a closed door meeting that Guyana requested to address Venezuela's moves to possibly seize the Essequibo Region.

"I think Venezuela found it hard to find a friend," a source told Demerara Waves Online News on condition of anonymity. "I think the meeting sent a very clear message to Venezuela and that was important," the official added.

The UNSC would likely issue a statement on the outcome of the meeting. President Irfaan Ali requested the UNSC meeting after Venezuela adopted a law that seeks to annex the 160,000 square kilometre Essequibo Region, despite orders by the World Court and a bilateral declaration that there must be no escalation of tensions.

Guyana's Permanent Representative to the United Nations, Carolyn Rodrigues-Birkett, was quoted by the Spanish news agency, Agencia EFE as saying that "a large majority" of the UNSC members demonstrated their support for Guyana's territorial integrity.

UN Security Council supports respect for territorial integrity, international law- Guyana 11 April 2024

No official statement has so far been issued by the Council, but the United Kingdom's 'X' feed at the UN said the Security Council met to discuss Venezuela's threats to Guyana's territory, and made that Western Nation's position clear on the issue. "Venezuela cannot act unilaterally to disrupt the peace of the region. The border was settled in 1899 through international arbitration and must be respected," the UK said.

Other sources told Demerara Waves Online News that Guyana received "strong support from the Western democracies" on the rule of international law, use of the International Court of Justice (ICJ) to settle the border dispute, maintaining peace in Latin America and the Caribbean, "strict adherence" to the ICJ's orders that Venezuela must not take any action against Guyana's administration and control of the Essequibo Region, and President Irfaan Ali and President Nicolás Maduro's Declaration for Dialogue and Peace.

One source familiar with the meeting said China and Russia's support were a "bit more nuanced but they weren't ambivalent which is good" and another said for those two UNSC Permanent Members it was more about bilateral relations and solving it (border dispute) bilaterally". However, Guyana continues to maintain that, based on a 1966 agreement, the ICJ is the proper mechanism to settle the dispute over the validity of the 1899 Arbitral Tribunal Award that settled the land boundary between the two South American neighbours.

UN Security Council supports respect for territorial integrity, international law- Guyana 11 April 2024

Back in December 2023, the Russian foreign ministry had said that "In our view, this is a matter of #Venezuela-#Guyana relations and should be settled in a neighbourly way."

Guyana enjoys diplomatic relations with China and Russia.

The 10 other non-permanent UNSC members, the sources, said, also supported the "rule of international law". "There was no dissent on support for Guyana and the respect for territorial integrity and the adherence to international law," one of the sources told Demerara Waves Online News.

Agencia EFE reported that Venezuela's Ambassador to the United Nations, Samuel Moncada Acosta, who was present at the session, ruled out any occupation plan, but Guyana's Permanent Representative to the UN, Carolyn Rodrigues-Birkett did not believe him because, according to her, "words say one thing and actions say another."

Venezuela has been repeatedly accusing Guyana of allowing the United States' establishment of secret military bases here to launch an attack on the eastern and northern part of that Spanish-speaking nation. In his effort to rally support for the July 28, 2024 elections, President Maduro has claimed that Guyana has been aligning itself with the US Southern Command, Central Intelligence Agency, ExxonMobil and the United Kingdom to take control of the Essequibo Region.

The "Security Council Report" website stated that in the letter that requested Tuesday's meeting, Ali cited the "Organic Law for the Defense of Guayana Esequiba", which Maduro signed on 3 April. He warned that this action "cements Venezuela's intent to annex more than two-thirds of Guyana's sovereign territory and make it part of Venezuela". Maduro described the law as the implementation of the results of the 3 December 2023 referendum. He added that the law "establishes the creation of state number 24, the state of Guayana Esequiba within the political and territorial organization of the Bolivarian Republic of Venezuela". The law also reiterated Venezuela's rejection of the validity of the 1899 Paris Arbitral Award and the ICJ's jurisdiction on the matter.

In his 5 April letter, Ali said that the law violates the ICJ's 1 December 2023 provisional measures and expressed concern that given Caracas' disregard of this order, "Venezuela's next move would be to implement its plan for the seizure of our sovereign territory". He added that such an act would be a breach of the fundamental principles of international law enshrined in the UN Charter and would contradict the letter and spirit of the Argyle Declaration. The letter also rejects recent claims made by Maduro that the US has installed CIA bases in Essequibo, calling it a "dangerous narrative".

STATEMENT FROM THE CARIBBEAN COMMUNITY COUNCIL OF FOREIGN AND COMMUNITY RELATIONS (COFCOR) ON THE ESCALATING MIDDLE EAST CONFLICT

April 14th 2024



The Caribbean Community Council of Foreign and Community Relations (COFCOR) views with grave concern the escalating violence in the Middle East, particularly the recent direct military engagements between Israel and Iran. These developments not only exacerbate the already tense situation but also pose significant threats to regional stability and international peace.

The continued cycle of retaliation, including the recent attack on Israel by Hamas, Israel's disproportionate response in Gaza, and the alarming new dimension of direct confrontations between Israel and Iran, leads to an untenable situation fraught with potential for greater regional conflict and global instability.

STATEMENT FROM THE CARIBBEAN COMMUNITY COUNCIL OF FOREIGN AND COMMUNITY RELATIONS (COFCOR) ON THE ESCALATING MIDDLE EAST CONFLICT

April 14th 2024



The human toll of this conflict, highlighted by tragic incidents such as deaths and injuries to children, demand an immediate and empathetic response from the global community. It is imperative that there be no further escalation that can lead to more suffering and instability.

In light of this critical situation, COFCOR urgently calls for:

- •An immediate cessation of hostilities between Israel and Iran. We strongly urge both nations to halt any further military actions that could worsen the situation, endangering not only their own populations but also the broader international community.
- •The international community, particularly the five Veto-nations on the UN Security Council, to work assiduously towards an immediate ceasefire, ensuring the provision of necessary humanitarian aid and fostering conditions conducive to a lasting peace
- ·All involved parties to re-engage in diplomatic dialogue, prioritizing peaceful resolutions and cooperation over military actions.
- As nations committed to the principles of justice and peace, the Caribbean Community stands ready to support efforts toward de-escalation and the establishment of a durable peace in the region.

CARICOM STATEMENT ON THE ESTABLISHMENT OF THE HAITIAN PRESIDENTIAL COUNCIL



The Heads of Government of the Caribbean Community (CARICOM) welcome the news today of the publication of the decree establishing the Transitional Presidential Council in Haiti. The establishment of the nine-member broad-based, politically inclusive Council signals the possibility of a new beginning for Haiti.

CARICOM has supported Haiti, its sister nation, through the challenging process of arriving at a Haitian owned formula for governance that will take the troubled country through elections to the restoration of the lapsed state institutions and constitutional government. Following on from the agreements reached in Kingston, Jamaica, on 11 March, which brought together a diverse group of Haitian political, private sector, civil society and faith-based stakeholders, the Transitional Presidential Council has devised a framework setting out the creation, organization and functioning of the Council, and arrived at a Political Accord that articulates the way forward.

The CARICOM Heads of Government fully endorse the principles of the Political Accord, and in particular take note of Article 16 which states, "The mission of the Presidential Council is to put Haiti back on the road to dignity, democratic legitimacy, stability and sovereignty and to ensure the proper functioning of the State's institutions".

It is also clear that one of the first priorities of the newly installed Presidential Council will be to urgently address the security situation so that Haitians can go about their daily lives in a normal manner; safely access food, water and medical services; children can return to school; women can move around without fear of horrific abuses; and so that businesses can reopen.

There are still daunting challenges ahead. CARICOM stands ready to continue to support the Haitian people and their leaders as they determine their future in a sovereign manner through this transitional period on the path to stability, security and long-term sustainable development for Haiti.

STATEMENT FROM THE COUNCIL OF FOREIGN AND COMMUNITY RELATIONS (COFCOR) ON CUBA



The Council for Foreign and Community Relations (COFCOR) welcomes the decision of the Government of the United States of America (USA) to remove the Republic of Cuba from its list of states that are "not cooperating fully" in its fight against terrorism.

COFCOR notes, however, that the Republic of Cuba remains on the US State Department's list of countries that have been deemed by the USA to be State Sponsors of Terrorism. COFCOR therefore, renews its call for the urgent removal of Cuba from the list of countries deemed to be State Sponsors of Terrorism.

COFCOR also reaffirms its rejection of the unilateral imposition by the United States of America of the economic, commercial, and financial embargo against Cuba. Both the designation as a State Sponsor of Terrorism and the 62-year-old embargo are unjust and wrongly imposed upon the Cuban people and must be terminated.
